# Midwifery - Advanced Practice (AMP)



## Course Overview

This course prepares suitably qualified, experienced midwives, who wish to pursue a career as an Advanced Midwife Practitioner, to develop their knowledge, skills and attitudes. The course provides the student with a broad-based education experience incorporating the key concepts of woman-centred care, autonomy and empowerment, professional ethics, consultation and collaboration and professional leadership thus enabling them to practice at the highest professional standards across the spectrum of care.

Upon successful completion of this course the graduate will be eligible to apply to the Nursing and Midwifery Board of Ireland for registration as a Registered Midwife Prescriber (RMP). Applicants who already have a Masters in Midwifery and who are active as a Registered Midwife Prescriber (RMP) may be eligible to complete a one year Postgraduate Certificate in Advanced Practice. (AMP); provided that the modules “Advanced Practice in the Clinical Practicum with defined pathways” and “Decisions Making, Nursing and Advanced Practice Professional Roles” modules have been successfully completed and 30 ECTS have been accumulated.

### Structure and delivery

**Year One:** Normally commences with a full week in September and thereafter generally one to two days per week for the remainder of the academic year.

**Year Two:** Attendance at workshops and classes throughout the academic year.

A blended learning approach is utilised in the delivery of theoretical content which includes lectures, group discussions and self-directed learning. The assessment process is a combination of written and practical assignments. Students undertaking the M.Sc./P.Grad.Dip./P.Grad.Cert. in Midwifery-Advanced Practice (AMP) are required to work in their area of practice for a minimum of 500 hours during Year One. This clinical placement takes place under the supervision of an experienced senior clinician.

### Year One

- Professional, Ethical, Legal and Communication Issues informing Nurse and Midwife Prescribing and Clinical Practicum (10 ECTS)
- Decision Making, Midwifery and Advanced Practice Professional roles (10 ECTS)
- Advanced Health Assessment (10 ECTS)
- Prescribing Medicinal Products & Ionising Radiation (10 ECTS)
- Advanced Practice in the Clinical Practicum with defined pathways (20 ECTS)

### Year Two

- Leadership, Quality Improvement and Governance (10 ECTS)
- Advanced Research Methods for Healthcare Professionals (10 ECTS)
- Dissertation in Advanced Practice (30 ECTS)

Students who already hold an M.Sc. in Midwifery or an allied health sciences subject may be eligible to exit at the end of year one with a Postgraduate Diploma in Midwifery- Advanced Practice.

### Entry Requirements

#### Academic Criteria

1. Hold an honors degree in Midwifery Studies or equivalent; and
2. Or otherwise satisfy the course committee that they have the ability to complete and benefit from the course, subject to the discretion/permission of the Dean of Graduate Studies.

#### Professional Criteria

3. Current registration on the relevant Nursing Division maintained by the Nursing and Midwifery Board of Ireland; and
4. Have a minimum of three years post-registration clinical experience during the last five years with at least one year full-time experience in the specific area of practice.
5. Have received a written commitment from host organisation to support the student for the clinical practicum (to include prescribing of medicinal products and ionising radiation)
6. The host hospital must obtain a satisfactory clinical audit as a suitable learning environment for the relevant speciality

Students who already hold a MSc in Midwifery or relevant subject and who meet the professional requirements as set out above, may be eligible to complete a one year postgraduate diploma in Advanced Practice.

### Documentation required to complete application

- A copy of current Nursing and Midwifery Board of Ireland registration.
- 1 academic and 1 professional reference.
- Copies of academic transcripts from completed educational courses.
- Copies of official awards (parchments) from completed educational courses.
- Written commitment from the Director of Midwifery to support the student during the clinical practicum and to nominate a suitably qualified practitioner to act as a clinical supervisor/mentor during the student's clinical learning experience.
- A site declaration form signed by the Director of Midwifery must be submitted with the student's application. This must also be signed by the Medical Practitioner/Registered Advanced Midwife Practitioner who will act as clinical supervisor.
